LATE RESOLUTIONS / EMERGENCY RESOLUTIONS

The deadline for resolutions has now passed. Late resolutions must still be approved by the submitting body (i.e. Local, regional committee, area council) and submitted online in either traditional format or clear language. Please note any resolution exceeding the 150 words **will NOT** be accepted. Late resolutions will only be debated once all convention items have been completed.

Late resolutions that are, in the opinion of the Chair, of an emergency nature shall be debatable at any time. An emergency resolution is an emergent matter that has occurred after January 24 up till convention.

ELECTIONS

The following positions will be elected at the 2023 Prairie Region Triennial Convention (subject to any By-law changes):

- Regional Executive Vice-President (REVP)
- Alternate REVP (and one Alternate)
- One representative for each of the following six geographical areas: Northern Alberta, Southern Alberta, Northern Saskatchewan, Southern Saskatchewan, South-East Manitoba, North-West Manitoba (and two (2) Alternates for each position)
- One representative for Regional Women's Committees (and two (2) Alternates)
- One representative for Indigenous Peoples (and two (2) Alternates)
- One representative for Persons With Disabilities (and two (2) Alternates)
- One representative for Racially Visible Persons (and two (2) Alternates)
- One representative for LGBTQ2+ (and two (2) Alternates)
- One representative for Directly Chartered Locals (and two (2) Alternates)
- One representative for Young Workers (and two (2) Alternates)
- One representative for Separate Employer Locals (and two (2) Alternates)

Nominations for REVP, 1st Alternate REVP, 2nd Alternate REVP and all Prairie Region Council positions will open at **12:00pm Noon (MB/CST), April 11, 2023. Nomination forms and instructions for submission will be posted on the Prairie Region website.**
