It has proven that workers are less stressed and therefore more productive when working remotely; Be it Resolved; that PSAC Prairies ask PSAC National to lobby federal governments to maximize remotely initiatives.

Be it Further Resolved; that PSAC include this concept as a bargaining demand in other bargaining units"

• summary of feedback: narrower/more specific focus to wording (focusing on worker

impact), resolution should have a specific request for what is being asked for, resolution should also be more inclusive of non-federal public service workers who are also represented by the union

• Final wording:

"WHEREAS Treasury Board has announced the Hybrid work model is the future of the public service and is here to stay, and

WHEREAS Remote work is the practice of employees doing their jobs from a location other than a central office operated by the employer. It has proven to have broad benefits to workers, such as workers being more productive and less stressed.

BE IT RESOLVED THAT PSAC National develop a campaign to advocate for remote work in the Federal Public Service, Separate Agencies, DCLs and Federal Employees broadly; and

BE IT FURTHER RESOLVED THAT PSAC provide all necessary staff resources to support a working group for the campaign."
